The GLAMURS project has investigated the influence of time on engagement with sustainability. Increasingly, wealth is associated with high demands on time, and existing research has already shown that under stress, people are less likely to make mindful, rational decisions. This results in choices that are not necessarily best for the individual, never mind wider society, the environment, or the economy. 





#### Directions to the venue
